EMS CONTINUING EDUCATION**

There will be a non-mandatory "Prehospital Management of the Collapsed Athlete 2021" assignment for all EMTs, Paramedics, ECRNs, and ECPs in the Region 11 EMS System that will begin today, September 29, 2021. This will be a one (1) hour Continuing Education (CE) assignment. There is no due date for this assignment, but EMS providers working the day of the Chicago Marathon and other similar events are encouraged to complete this education.

For EMTs and Paramedics, this education is available on the Region 11 EMS Vector Solutions e-learning system and you should receive notice of the assignment through the email you have linked to your Vector Solutions account. It is important to read all the documents and view the complete video prior to attempting the test. Users that do not achieve a 75% score after three attempts will not receive credit for the assignment and should contact their Resource Hospital if they would like to receive credit for this education. On successful completion, users will earn one (1) hour of Continuing Education in the Medical Core Content Category.

For all ECRNs and ECPs, the education may be provided through your EMS Coordinator or EMS Medical Director and one hour of ECRN CE will be provided.
